The inspection was conducted on August 18 and 25, 2021. This inspection was assigned due to the violations found at the licensee's other location (5-75-40839) in Nocona, Texas and the fact that both licenses utilize the same EPICOR A&D system.

Onsite End Date

The licensee's Nocona location was found to have violations with the A&D record and they were not in compliance with their electronic ATF F 4473. The same violations were found at this location. Additional violations were discovered when comparing the Nocona A&D record to the Muenster A&D record as the licensee is not properly transferring firearms between the two licenses.

The licensee utilizes EPICOR, an electronic A&D record and utilizes EPICOR for electronic ATF Forms 4473. The licensee is not in compliance with ATF Ruling 2016-2 as the licensee is doing the entire form electronically (to include NICS check), printing it and then the customer signs after everything is completed.

IQ (b)(6) compared all ATF Forms 4473 for the past year to the A&D book with no discrepancies. Investigator (b)(6) compared the entire Muenster A&D record to Nocona's (b)(3) (112 Public Law 55 125 Stat 552) [10] (b)(6) asked Terry Luke to call Melvin Luke to see when the stransferred back to Muenster from Nocona.

to make a copy of the information for the four firearms in question and Terri Luke stated she did not need a copy because it was too long ago and she had no idea where the firearms were. There were other transfers between the Muenster and Nocona location that date back to when each store utilized a manual A&D book. IOI. 19(6) reviewed the manual A&D books for both locations to ensure all information was reviewed.

Terri Luke stated she did an inventory six months ago, but there was a firearm logged out on 12/20/2020 that was in inventory that she did not catch. Terrie Luke would not explain how she conducts her inventory

There were no theft/losses.

The licensee was associated with ace. No further action is required.

There was one denial. The firearms listed on the denied ATF Form 4473 were sent back Grab-A-Gun, so there was no straw purchase.

The licensee does not sell used firearms.

There were no discrepancies with the two NTNs on the FFL Audit log.

The period of inspection was August 19, 2020 through August 19, 2021, for the ATF Forms 4473. The A&D record was reviewed in its entirety. The licensee transferre firearms to (b)(3) (112 Public Law 55 125 Stat 552)

During the closing conference, Investigator (b)(6) asked if the licensee had looked into whether or not their electronic ATF Form 4473 could be converted to accept signatures like their Nocona store. Terri Luke stated she had not looked into it. IOI. (2009). h advised Terri Luke that Melvin Luke stated he was going to look at the system on the night of 8/19/2021, and asked Terri Luke if he had. Terri Luke stated they have been too busy for either of them to look at the system. IOI (b)(e) again advised Terri Luke she could not use the electronic ATF Forms 4473 as the system currently was, and Terri Luke stated she understood. Terri Luke stated she had not sold any firearms since IOI (b)(b) left on 8/19/2021.

Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given that the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intends to revoke the Federal firearms license held by A F Luke Enterprises, Inc. ("Licensee"), a Dealer in Firearms Other Than Destructive Devices. Specifically, the Director, Industry Operations, United States Department of Justice, ATF, Dallas Field Division, has reason to believe that Licensee willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

Compliance History

ATF first issued a Federal firearms license to Licensee in 2013. The laws and regulations issued under the GCA were reviewed as part of the application inspection. Subsequently, ATF conducted a compliance inspection of Licensee in 2018. The laws and regulations issued under the GCA were again reviewed as part of the compliance inspection.

Current Inspection

On August 18, 2021, ATF began a compliance inspection of Licensee's premises that revealed the following:

Acquisition and Disposition Record Violations:

- Or occasions, Licensee willfully failed to timely and/or accurately record the acquisition of firearms, in violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.125(e). See Appendix, ¶ 1
- On occasions Licensee willfully failed to timely and/or accurately record the disposition of firearms I violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.125(e). See Appendix, ¶ 2

Background Check Violations:

Although the Notice to Revoke was served upon the Licensee on January 3, 2022, no request for hearing was filed with ATF within 15 days of the date on which the Notice was served.

For the reasons set forth in the Notice to Revoke or Suspend License and/or Impose a Civil Fine issued on December 20, 2021, the Federal firearms license held by AF Luke Enterprises. Inc. dba Ace Hardware is hereby REVOKED.
