Specifically, a violation of 27 CFR 102(a) for failure to conduct a NICS background check in two instances. In both instances, the licensee accepted an out-of-state (Texas) concealed carry permit. Further investigation revealed that neither purchaser was/is prohibited.

A Warning Letter was previously issued to the licensee to address the non-compliance issues identified during the current inspection.

Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given that that the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intends to revoke the Federal firearms license held by Kristina Kaye Cosper, doing business as Lead Valley Gunworks ("Licensee"). Specifically, the Director, Industry Operations, United States Department of Justice, ATF, New Orleans Field Division, has reason to believe that Licensee willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

# **Compliance History**

ATF first issued a Federal firearms license to Licensee in 2020. The laws and regulations issued under the GCA were reviewed as part of the application inspection. Subsequently, ATF conducted a compliance in 2021.

# **Current Inspection**

In 2021, the ATF compliance inspection of Licensee's premises revealed that on two occasions, Licensee willfully transferred firearms to an unlicensed person without first contacting the National Instant Criminal Background Check System ("NICS") and obtaining a unique identification number and/or waiting three days before allowing the transfer, in violation of 18 U.S.C. § 922(t) and 27 C.F.R. § 478.102 when transferring firearms to (b)(6) on May 1, 2021 and June 1, 2021.

Kristina Kaye Cosper, d/b/a Lead Valley Gunworks ("Licensee") holds a Federal firearms license # 5-71-131-01-3J-06194 issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") pursuant to the Gun Control Act of 1968 ("GCA"), as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27C.F.R. Part 478 (collectively GCA).

On March 1, 2022, ATF issued a Notice to Revoke or Suspend and/or Impose Civil Fine, ATF Form 5300.4 (4500), to Licensee. The Notice was mailed with the United States Post Service (USPS) by certified mail, return receipt requested. The USPS delivered the notice on March 10, 2022.

The Notice alleged Licensee willfully violated the provisions of the GCA. The Notice further specified that if Licensee wanted a hearing to review the notice, she should file a request with ATF for such hearing within 15 days after receipt of the notice and in accord with 18 U.S.C. § 923(f)(2) and 27 C.F.R. § 478.73(b).

No request for hearing was timely filed or received.

For the reasons set forth in the Notice of Revocation, the Federal firearms license held by Kristina Kaye Cosper, d/b/a Lead Valley Gunworks is hereby REVOKED.
