Director of Industry Operations (b)(6) Recommendation Revocation Details During this inspection, there were 4 violations cited. One violation warrants a recommendation of revocation for failure to initiate a new NICS check after a 30-day
lapse of the initial check based on the Administration's Comprehensive Strategy to Prevent and Respond to Gun Crime and Ensure Public Safety. This violation occurred in one instance. A background check was conducted on the customer and the customer is not prohibited under the GCA. The RP stated he believed the error occurred because both
The FFL was received in 2013 and two compliance inspections have been conducted. One in 2014 and one in 2019. Both inspections had a recommendation of no violations.
There were no missing firearms, no traces, no unreported multiple sales, no reported thefts or loses during the inspection period or as a result of the inspection and no transfers to prohibited persons.
There were no extraordinary circumstances disclosed; therefore, based on the current policy, a recommendation of revocation is proposed.
Area Supervisor (b)(6) Recommendation Revocation
Details Based on ATF O 5370.1E, Federal Firearms Administrative Action Policy and Procedures, as a result of the Comprehensive Strategy to Prevent Gun Crime (July 14, 2021), and the inspection findings I am recommending revocation of license. The licensee failed to initiate a new NICS check when the transaction was not completed within the 30-day period from the date of NICS was initially contacted.
Industry Operations Investigato (b)(6) Recommendation Warning Conference Details
The inspection of Lohman Arms Company, LLC dba Lohman Gunsmith resulted in the licensee being cited for four violations. One violation, failure to initiate a new NICS check after 30-day lapse of initial check warrants a recommendation of Revocation under ATF Order 5370.1E. The customer, who was transferred the firearm more than 30 days after NICS was originally contacted, was queried in OmnixxForce with no prohibiting information found.
The Comprehensive Strategy to Prevent Gun Crime, ATF Order 5370.1E and revocation of Firearms License (https://www.atf.gov/firearms/revocation-firearms-licenses) states the violation must be willful to justify revocation. Lohman Arms Company, LLC has held this license since January 16, 2013 and has no history of not conducting a background check or other violations, which would potentially justify revocation other than this one instance of failing to initiate a new NICS check after 30-day lapse of initial check. It appears this violation was a result of inadvertence; therefore, we should assist the licensee in taking corrective actions to ensure the violation is not repeated and the licensee achieves full







Chapter 44 and the regulations issued thereunder, 27 C.F.R. Part 478 ("collectively, "GCA") as described herein.

Compliance History

ATF issued a Federal firearms license in January 2013. The laws and regulations issued under the GCA were reviewed as part of the application inspection with responsible person, Brian Lohman. ATF conducted compliance inspections of Licensee in March 2014 and June 2019 during which the laws and regulations issued under the GCA were again reviewed with Brian Lohman.

Current Inspection

On February 8, 2022, ATF began a compliance inspection of Licensee's premises that revealed the following:

Lohman Arms Company LLC, ("Licensee"), holds Federal Firearms License 5-76-201-01-5B-03812 issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") pursuant to the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

On June 30, 2022, ATF issued a Notice to Revoke or Suspend Licensee and/or Impose a Civil Fine, ATF E-Form 4500 (5300.4) ("Notice to Revoke License") advising Licensee that ATF intended to revoke its License. The Notice to Revoke alleged that Licensee willfully violated the provisions of the GCA, and the regulations issued thereunder. The Notice to Revoke further specified that if Licensee wished to challenge the revocation, it may file a request with ATF for a hearing "within 15 days after receipt of this notice." See 18 U.S.C. § 923(f)(2); 27 C.F.R. § 478.73(b).

By letter dated July 14, 2022, Licensee timely requested a hearing to review the Notice to Revoke License. As a result, ATF notified Licensee that the hearing would occur on August 25, 2022.

On August 23, 2022, Licensee, through its attorney, emailed the Director of Industry Operations and Division Counsel of the Houston Field Division indicating that it was surrendering its license, effective August 24, 2022.

For reasons set forth in the Notice to Revoke License issued on June 30, 2022, License for Lohman Arms Company LLC is hereby REVOKED with an effective date of August 24, 2022.
