IOi (b)(6) conducted a background check on the individual that used an expired CHL, via NCIC/NLETS and NForce. No firearm prohibitions disclosed, and no cases discovered. Licensee did not have any unresolved traces and no missing firearms disclosed during the inspection.

REVOCATION is recommended for the following reasons:
The current recall inspection was completed on 10/13/2021 at the business premises of MADISON SPORTING ARMS LLC dba MANSFIELD SPORTING ARMS. Licensee was cited for nine violations, to include one (1) instance of accepting an invalid/expired Concealed Handgun License (CHL) in lieu of completing a NICS/POC background check. This was the only violation that warranted administrative action.
Factors taken into consideration when making this recommendation included the fact that this was the licensee's fourth compliance inspection. The licensee has held the license since 2010. Licensee's first compliance inspection resulted in no violations. The licensee was subject to two Area Supervisor Held Warning Conference on the previous two inspections. The licensee made significant improvement in the overall number of instances cited from the previous two inspections. Licensee also completed imore Forms 4473 in the most recent compliance inspection than in the 2020 inspection. There were inspection in the current inspection and added a firearm to a 4473 when a customer would return to purchase an additional firearm within 30 days of their first purchase. License stated, he thought a NICS check was good for 30 days and he could add the firearm to the form. This violation was not repeated in the recent inspection and queries revealed there were no transfers to prohibited persons.
In reference to the 478.102(d)(1) violation cited in the current inspection, licensee accepted one expired CHL in lieu of conducting a NICS check. The licensee transferred a (b)(6) ion 1/20/2021, and accepted his expired State of Ohio CHL in-lieu of conducting a NICS background check. The CHL was issued by Richland County and expired on 7/28/2020. Wallace Toward (Owner/Responsible Person) stated, he just screwed up, and that he had received (b)(6) Mr.
Toward stated, "I can't see that well. It was just a mistake." It should be noted Mr. Toward was also (b)(6)



Furthermore, Licensee recorded "Disposition" of firearms when sent to the gunsmith and "Acquisition" of firearms when they returned to the business premises, resulting in disposition dates recorded as prior to acquisition dates. Licensee was cited for a single violation of failure to properly maintain an accurate acquisition and disposition record as the "Out of Shop" book was missing most of the required information for multiple firearms.

Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given that that the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intends to revoke the Federal firearms license held by Madison Sporting Arms, LLC ("Licensee"). Specifically, the Director, Industry Operations, United States Department of Justice, ATF, Columbus Field Division, has reason to believe that Licensee willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

# **Compliance History**

ATF first issued a Federal firearms license to Licensee in 2010. The laws and regulations issued under the GCA were reviewed as part of the application inspection. Subsequently, ATF conducted license renewal qualification inspections for Licensee in 2015 and 2019 and compliance inspections in 2015, 2018, and 2020. The 2018 and 2020 compliance inspections both resulted in a Warning Conference with the Industry Operations Area Supervisor. The laws and regulations issued under the GCA were reviewed at the end of these inspections and warning conferences and Licensee was informed that any future violations, repeat or otherwise, could be viewed as willful and may result in revocation of its license.

# **Current Inspection**

On October 13, 2021, ATF completed a recall compliance inspection of Licensee's business that revealed the following:

# **Background Check Violations:**

1. On one occasion, Licensee willfully transferred a firearm to an unlicensed person without first contacting the National Instant Criminal Background Check System ("NICS") and obtaining a unique identification number and/or waiting three days before allowing the transfer, in violation of 18 U.S.C. § 922(t) and 27 C.F.R. § 478.102.
