On June 14, 2022, ATF issued Licensee a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF 4500 (5300.4), ("Notice") for violations of the Gun Control Act ("GCA") cited as the result of the compliance inspection commencing on January 28, 2022. The referenced Notice is attached as Appendix A.

After receipt of the Notice, Licensee requested to meet with the Director, Industry

Operations ("DIO") William Miller to address the violations cited in the Notice and how the
matter could be resolved.

On June 27, 2022, the parties attended a telephonic conference to discuss possible resolution of the violations. During that meeting, Licensee, by and through the licensed business' owner and responsible person Daniel L. Bucher, stated that Licensee did not wish to have a hearing on the Notice or contest the violations and requested time to sell/transfer the remaining inventory in accordance with the requirements of the GCA. The parties reached an Agreement in principle which is set forth in a binding form as further detailed herein.

### <u>Agreement</u>

ATF and Licensee hereby stipulate and agree as follows:

- 1. This Agreement is being entered into solely for the purpose of settling the current administrative action against Licensee's Federal firearms license as set forth in the Notice;
- 2. The stipulations in this Agreement are solely for the purpose of settling this action.

  The stipulations shall not serve as an acknowledgment or admission of any criminal act,

  administrative/regulatory violation, or other wrongdoing by Licensee or Licensee's responsible

  person Daniel L. Bucher, other than for the purposes specifically stated in this Agreement;
- 3. Notwithstanding the preceding paragraph, this Agreement may be introduced and/or utilized for purposes of establishing "willfulness" at any future administrative proceeding relative to any application for a Federal firearms license by Licensee or by Daniel L. Bucher or for an Federal firearms license application in which Daniel L. Bucher is designated or would otherwise be involved as a responsible person;
- 4. Licensee has not requested a hearing on the revocation of its license and does not contest the violations alleged in the Notice, and its license shall be revoked as further stated in this Agreement;
- 5. ATF shall issue a Final Notice of Revocation, ATF Form 5300.13, and Findings of Fact and Conclusions of Law in accordance with 27 C.F.R., Part 478, Subpart E, which shall set forth the effective date of revocation as August 15, 2022;
- 6. Notwithstanding the preceding paragraph, if the DIO determines that Licensee is in the process of lawfully selling its business inventory in good faith and has made substantial steps towards final liquidation, the DIO, in his sole discretion, may permit Licensee to continue operations beyond August 15, 2022, for a reasonable period of time as determined by the DIO.

In the event Licensee believes good cause exists to extend the revocation date, Licensee shall file any extension request for consideration with the DIO at least ten (10) business days prior to August 15, 2022;

- 7. The licensed business shall not acquire any additional firearms during this time period and may only liquidate existing inventory.
