
Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given that the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intends to revoke the Federal firearms license held by PDW Solutions, Inc.("Licensee"). Specifically, the Director, Industry Operations, United States Department of Justice, ATF, New Orleans Field Division, has reason to believe that Licensee willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

ATF first issued a Federal firearms license to Licensee in 2018. The laws and regulations issued under the GCA were reviewed as part of the application inspection. Prior to this license, Responsible Person, George Peterson, held a Federal Firearms License as a managing member of 10-8 Tactical Gear and Supply LLC which held Federal firearms license number 5-71-051-01-0F-01858 (b)(6),(b)(7)(C)

A review of the licensee's records revealed numerous violations of the law and regulations, including but not necessarily limited to the following:

On 37 occasions, Licensee willfully transferred a firearm to an unlicensed person without first contacting the National Instant Criminal Background Check System ("NICS") and obtaining a unique identification number and/or waiting three days before allowing the transfer, in violation of 18 U.S.C. § 922(t) and 27 C.F.R. § 478.102 when transferring firearms as follows:

The Notice further specified that if Licensee wanted a hearing to review the notice, a request with ATF for such hearing should be filed within 15 days after receipt of the notice and in accord with 18 U.S.C. § 923(f)(2) and 27 C.F.R. § 478.73(b).

No request for hearing was timely filed or received.

For the reasons set forth in the Notice of Revocation, the Federal firearms license held PDW Solutions, LLC. is hereby REVOKED.
