#### Warning Conference

Details

Concur with the Area Supervisor with a recommendation of Warning Conference in lieu of Revocation due to the fact that this is the licensee's first compliance inspection since obtaining their license on May 5, 2020. Their qualification inspection was conducted via telephone due to the COVID pandemic. The NICS violations that warrant revocation were discussed with the licensee. The licensee misunderstood the requirements for accepting out of state CCW permits and therefore that is why no NICS checks were conducted in five instances. The licensee stated that they believed the three business days requirement prior to transfer of a firearm with an initial delayed response was referred to their posted business days. The licensee has been educated on the Federal laws and regulations and the licensee has stated that they now understand the requirements. No individuals were prohibited and no public safety issues seen at this time. A recall inspection will be required.

Area Supervisor (b)(6) Recommendation Warning Conference

Details

As a result of a compliance inspection conducted from September 8, 2021, through September 23, 2021, a Report of Violations was issued. The results of this inspection warrant revocation based on the licensee's failure to conduct a NICS Check prior to transfer of a firearm to a non-licensee on five occasions and for failing to wait three business days (with no NICS/POC response) to transfer a firearm on one occasion. However, an alternate recommendation of Warning Conference is being offered for the following reasons: This is the licensee's first compliance inspection since obtaining their FFL on May 5, 2020. The licensee stated that they misunderstood the requirements for accepting out of state Carry Concealed Weapon (CCW) Permits. They now understand that only valid Arizona CCW Permits are allowed to be accepted. The licensee further stated that they believed the three business days requirement referred to their posted business days. They now understand the three-business day requirement.

All of the individuals identified in the above-mentioned transfers were run through NCIC and Accurint with no prohibiting information found. At the time of this inspection, the licensee was not associated with any traces. Since the inspection the licensee has had successful trace involving a purchaser who was referred to CE for further investigation. No additional evidence of trafficking or any connections to public safety were identified. There were no missing firearms. This is the licensee's first compliance inspection since their license was issued on May 5, 2020.

Due to the issues presented by the COVID 19 Pandemic, the application was completed via telephone on April 30, 2020.



Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given that that the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intends to revoke the Federal firearms license held by Range Time LLC, 14647 South 50<sup>th</sup> Street, Suite 128, Phoenix, Arizona 85044 ("Licensee"), a Manufacturer in Firearms Other Than Destructive Devices. Specifically, the Director, Industry Operations, United States Department of Justice, ATF, Phoenix Field Division, has reason to believe that Licensee willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively, "GCA") as described herein.

### Compliance History

ATF first issued a Federal firearms license to Licensee in 2020. The laws and regulations issued under the GCA were reviewed with Licensee Responsible Person Timothy Sean Sante as part of the application inspection.

### Current Inspection

Beginning on or about September 8, 2021, ATF Industry Operations Investigator (b)(6) conducted a compliance inspection of the licensee's premises that covered the period of September 8, 2020 to September 8, 2021. The inspection revealed the following:

#### **Background Check Violations**

1. On four occasions, the Licensee willfully transferred a firearm to an unlicensed person without first contacting the National Instant Criminal Background Check System before allowing the transfer, in violation of 18 U.S.C. § 922(t) and 27 C.F.R. § 478.102(a). See Appendix.

Range Time LLC ("Licensee"), holds Federal firearms license 9-86-013-07-3F-15264 issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) pursuant to the Gun Control Act of 1968 (GCA), as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively "GCA").

On March 21, 2022, ATF issued a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500 (5300.4) (Notice to Revoke) advising Licensee that ATF intended to revoke its License. The Notice to Revoke was served upon Licensee via email, with acknowledgment that it was received, on March 29, 2022.

The Notice to Revoke alleged that Licensee willfully violated the provisions of the GCA. The Notice to Revoke further specified that if Licensee wanted a hearing to review the Notice, it should file a request with ATF for a hearing within 15 days after receipt of this notice and in accord with 18 U.S.C. § 923(f)(2) and 27 C.F.R. § 478.73(b).

No request for hearing was timely filed or received.

For the reasons set forth in the Notice to Revoke or Suspend License and/or Impose a Civil Fine issued on March 21, 2022, the Federal firearms license held by Range Time LLC is hereby REVOKED.

#### IMPORTANT NOTICE

#### Selling Firearms AFTER Revocation, Expiration, or Surrender of an FFL

Former Federal Firearms licensees (FFLs) who continue to sell firearms after the revocation, expiration, or surrender of their license are subject to the same rules as persons who have never been licensed in determining whether they are "engaged in the business" of selling firearms without a license in violation of 18 U.S.C. § 922(a)(1)(A). Accordingly, former licensees who wish to dispose of any remaining business inventory must adhere to the following guidance:

Business inventory must be disposed of by the former FFL in a manner that, objectively, does not constitute being engaged in the business of dealing in firearms using the same facts and circumstances test that would apply to persons who have never been licensed.

The preferred manner of disposition is for the former licensee to:

- Arrange for another FFL to purchase the business inventory (and other assets) of the business; or
- · Consign the inventory to another FFL to sell on consignment, or at auction.

Should a former FFL decide against those options, he/she should be aware that future sales - whether from his/her personal firearms collection or otherwise - will be evaluated for a potential violation of 18 U.S.C. § 922(a)(I)(A), just as would occur with a person who had never been licensed.

If a former FFL is disposing of business inventory, the fact that no purchases are made after the date of license revocation, expiration, or surrender does not immunize him/her from potential violations of 18 U.S.C. § 922(a)(I)(A). Instead, business inventory acquired through repetitive purchases while licensed are attributed to the former FFL when evaluating whether subsequent sales constitute engaging in the business of dealing in firearms without a license.
