Western Pawnbrokers Inc., 2817 Montana Ave., Billings, Montana, 59101 (Licensee), holds Federal Firearms License 9-81-111-02-3B-35123 as a dealer (pawnbroker) of firearms other than destructive devices issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) pursuant to the Gun Control Act of 1968 (GCA), as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478.

On December 2, 2021, ATF issued a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500 (5300.4) (Notice to Revoke) advising the Licensee that ATF intended to revoke its License. The Notice to Revoke was served upon the Licensee, via certified mail.

The Notice to Revoke alleged that the Licensee willfully violated the provisions of the GCA and the regulations issued thereunder. After receipt of the Notice to Revoke, the Licensee through counsel negotiated a settlement with ATF, whereby it agreed to surrender the License and acknowledged that ATF would issue a Final Notice of Revocation of the License.

For the reasons set forth in the Notice to Revoke or Suspend License and/or Impose a Civil Fine issued on December 2, 2021, the Federal Firearms License held by Western Pawnbrokers Inc, is hereby revoked.
