## FESD MISSION

Promote the ATF mission to prevent terrorism, reduce violent crime and protect the public by:

- 1. Ensuring that only qualified persons get access to firearms and explosives through stringent license screening;
- 2. Ensuring that only lawful defense articles are imported into the U.S. from lawful foreign countries for lawful purposes; and
- 3. Ensuring that possession of Federally-restricted weapons such as machineguns, silencers, short-barreled rifles and shotguns, and destructive devices is limited to lawful owners for lawful purposes.

#### Examiner/Specialist Updates

## NATIONAL FIREARMS ACT BRANCH (NFA)

- Out of the approximately 200,000 applications received in FY13, NFA processed 163,542 applications to manufacture, import, transfer, and export National Firearms Act Firearms (NFA). Over 72,033 applications submitted involved an non-licensed/exempt entity (e.g., trust, corporation, etc.)
- Average monthly revenue collected in FY 13 was \$1,578,000. Full year NFA revenue collections was \$22,475,251. In FY 2014 (December 2013) we hit an all time high of revenue collections of \$2.5M in one month.
- Responded to an average of 8,838 calls per month from industry members, public and law enforcement community inquiring about the rules, policies and application status of NFA applications.
- FY 13, NFA received 44 congressional inquiries in addition to 80 freedom of information act (FOIA) requests. This FY by midyear we have received over 44 congressional inquiries.
- The average processing time for forms 1 & 4 have been reduced to slightly less than 9 months.





### NFA Applications Received vs. NFA Staffing Levels




- Since FY 11, NFA Application receipts have consistently exceeded what could be physically processed.
- During this same period, ATF has experienced a 30% year-over -year increase in application receipts.
- ATF is projected to receive approximately 211,275 applications by the end of FY 14.

- LIE staffing levels remained relatively constant from FY 09 to FY 13.
- Without an increase in staff through FY 2013, ATF examiners have been only able to continually process more applications each FY through allocated OT resources.




# Monthly Average Number of Forms Received vs. Average Number Processed by Fiscal Year



### Increased NFA Workload


(Applications Received vs. Processed by FY)



- 1,152,163 weapons processed in FY 13 with already 0.87 million weapons processed in FY 14.
- Addressed over <u>106,000</u> customer service calls in FY 13 and averaging over <u>9,000</u> calls per month in FY 14.
- In excess of 72,000 of the applications received in FY 13 were from an exempt entity such as a Trust, unlicensed LLC, or corporation.
- Licensed NFA SOT Taxpayers have increased from 3,605 in FY 09 to 6,322 presently marking a 75% increase in membership.



#### **ATF Efforts to Reduce NFA Pending Applications**



- In FY 14, mitigating the workload increase & staffing shortfalls with overtime use, cross training of non- NFA personnel to assist with processing, initiation of data entry contract surges and modifications to increase level of effort have all contributed to the 31% pending application reduction.
- 15 new examiners selectees are in the employment pipeline; background check process has been our largest reason for delayed on-boarding (9 have commenced work with ATF).
- Business processes are continually adjusted to maximize efficiency; increase in personnel resources will be required in FY 15 to ensure productivity exceeds incoming projected workload.

## Firearms and Explosives Imports Branch (FEIB) Highlights

## International Imports Certificate

ATF provided comment to the U.S. Department of Commerce in December 2013 regarding the renewal/revision of the International Import Certificate.

Recommended several technical amendments to include properly identifying ATF under the U.S. Dept of Justice.

Recommended term of validity for the certificate to be at least 12 months.

ATF will continue to process IICs for defense articles enumerated on the USMIL and/or commodities requiring an ATF Form 6. IICs will be processed by Dept of Commerce for those not falling under ATF jurisdiction.

## Firearms and Explosives Imports Branch (FEIB) Highlights

## Import restrictions & required authorizations

U.S. State Department waivers are required in certain circumstances prior to ATF approving an importation. The following falls under State Department jurisdiction and will require a Letter of Authorization to accompany ATF Import Permit application:

- Proscribed Countries waivers
- Re-Transfer Authorizations




# FEDERAL FIREARMS LICENSES BY TYPE



# The Federal Explosives Licensing Center (FELC)


- Services over 10,496 explosives licensees and permittees.





**NFA Firearms Processed FY 13**
