Range Time LLC ("Licensee"). holds Federal firearms license 9-86-013-07-3F-15264 issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) pursuant to the Gun Control Act of 1968 (GCA), as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478 (collectively "GCA").

On March 21, 2022, ATF issued a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500 (5300.4) (Notice to Revoke) advising Licensee that ATF intended to revoke its License. The Notice to Revoke was served upon Licensee via email, with acknowledgment that it was received, on March 29, 2022.

The Notice to Revoke alleged that Licensee willfully violated the provisions of the GCA. The Notice to Revoke further specified that if Licensee wanted a hearing to review the Notice, it should file a request with ATF for a hearing within 15 days after receipt of this notice and in accord with 18 U.S.C. § 923(f)(2) and 27 C.F.R. § 478.73(b).

No request for hearing was timely filed or received.

For the reasons set forth in the Notice to Revoke or Suspend License and/or Impose a Civil Fine issued on March 21, 2022, the Federal firearms license held by Range Time LLC is hereby REVOKED.
