Scorpios Omega Tactical, LLC

On February 2, 2022, the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") issued a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500 (5300.4) ("Notice") to Scorpios Omega Tactical, LLC, Federal Firearms License number 9-86-013-07-3K-15500. By letter dated February 18, 2022, Scorpios Omega Tactical, LLC responded to the Notice by timely requesting a hearing on the Notice. That hearing is scheduled to occur on April 14,2020. Scorpios Omega Tactical has advised ATF that by signing this agreement it surrenders Federal Firearms License number 9-86-013-07-3K-15500 and will not appear at a hearing. This document memorializes that agreement which serves the interests of justice.

- 1. The violations cited in the Notice factually took place as stated in the Notice, a copy of which is attached hereto as Attachment A.
- 2. Scorpio Omega Tactical, LLC does not contest that it committed the violations alleged in the Notice. It does contest that the violations were willful.
- 3. Execution of this Agreement does not prohibit Scorpios Omega Tactical, LLC's Responsible Persons Brandon O. Southland or Jane A. Short from submitting an application for a Federal firearms license in the future. However, ATF may include the acknowledged violations as a factual predicate for any action it takes regarding such application or any future license issued to Southland or Short, or in which either is a responsible person for a Federal firearms license.
- 4. Scorpios Omega Tactical, LLC agrees to cease all business operations requiring a federal firearms license within 30 days of execution of this document. This includes but is not limited to all purchases, receipts, and sales of firearms, ordering firearms for sale or transfer, gunsmithing and online selling and purchasing firearms. Furthermore, after ceasing operations Brandon O. Southland and Jane A. Short will not directly or indirectly engage in any firearms operations in

which a federal firearms license is required, including operating through a surrogate firearms licensee.

- 5. If Scorpios Omega Tactical, LLC finds a purchaser who will acquire its firearms business, ATF agrees to work with the purchaser in expediting the Federal firearms license application process. ATF will also request expedited processing of any pending NFA forms initiated by Scorpios Omega Tactical pursuant to this agreement.
- 6. Scorpios Omega Tactical, LLC may request an extension from ATF to keep its license active for the sole purpose of liquidating its inventory and completing the required ATF Forms and its Acquisition and Disposition Record. The decision to grant any extension is solely at the discretion of ATF's Director, Industry Operations, Phoenix Field Division.
