INDICTMENT

The Federal Grand Jury charges:

COUNT 1

(Felon in Possession of a Firearm)

On or about October 7, 2013 at Altus, Oklahoma, in the Western District of
Oklahoma,

----- **MIKE CHARLES MALDONADO**, -----

the defendant, having been convicted of a crime punishable by imprisonment for a term
exceeding one year, knowingly and unlawfully possessed firearms, that is 1) a Springfield
XDM, .40 caliber semiautomatic pistol, serial number MG142427; and 2) a Smith and
Wesson, 9mm semiautomatic pistol, serial number TBU4205, which were in and

affecting interstate commerce in that the firearms had previously crossed state lines to reach the State of Oklahoma.

All in violation of Title 18, United States Code, Section 922(g)(1).

COUNT 2
(Possession of Methamphetamine)

On or about October 7, 2013 at Altus, Oklahoma, in the Western District of Oklahoma,

----- **MIKE CHARLES MALDONADO**, -----

the defendant, knowingly and intentionally possessed a mixture or substance containing a detectable amount of methamphetamine, a Schedule II controlled substance.

All in violation of Title 21, United States Code, Section 844(a).
