The Federal Grand Jury charges:

COUNT ONE

On or about April 8, 2013, in Oklahoma County, within the Western District of Oklahoma,



the defendant herein, an alien who had been convicted of an aggravated felony on March 24, 2003, and after having been deported, removed and excluded from the United States on January 5, 2011, was found in the United States without having obtained the consent of the

Attorney General of the United States, or his successor, the Secretary of Homeland Security, to re-apply for admission into the United States.

All in violation of Title 8, United States Code, Section 1326(a), the penalty for which is found at Title 8, United States Code, Section 1326(b)(2).
