

The Federal Grand Jury Charges:

On or about October 19, 2013, in the Western District of Oklahoma,

----- GILBERTO SALVADOR CORTEZ-GARCIA, -----

the defendant herein, an alien who was removed from the United States on or about June 16, 2007, August 4, 2010, and August 9, 2012, was found to be knowingly in the United States, without having obtained the consent of the Attorney General or his successor, the Secretary of Homeland Security, to reapply for admission into the United States.

All in violation of Title 8, United States Code, Section 1326(a).
