The Federal Grand Jury Charges:

On or about May 25, 2012, in the Western District of Oklahoma,

the defendant herein, an alien who was removed from the United States on or about February 24, 2000, after being convicted of an aggravated felony, was found to be knowingly in the United States, without having obtained the consent of the Attorney General or his successor, the Secretary of Homeland Security, to reapply for admission into the United States.
