#### **Operation Sarasota Cartel II News Release**

SARASOTA, Fla. - February 4, 2014 - 2:30 p.m.

In August 2012, the Sarasota Police Department Bureau of Criminal Investigations began '**Operation Sarasota Cartel II.**' This was a joint investigation between the Sarasota Police Department, Drug Enforcement Administration (DEA) and the State Attorney's Office for the 12<sup>th</sup> Judicial District.

In January 2014, the investigation culminated with a series of search warrants. This was able to be completed by the Sarasota Police Department with the help of Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), the State Attorney's Office for the 12<sup>th</sup> Judicial District, and the DEA Tampa District Office which included members from the Bradenton Police Department and the Manatee County Sheriff's Office.

'Operation Sarasota Cartel II' utilized numerous investigative techniques leading to legally intercept telephone calls of suspected drug dealers and traffickers in the Sarasota area. "The narcotics coming into this area were meant for the Sarasota and Bradenton area. The amount of drugs, money and cars we seized are of historic value for the Sarasota Police Department," said Lt. Pat Ledwith, Bureau of Criminal Investigations, Sarasota Police Department.

#### 18-Month Investigation Facts:

- \$115,000 seized in U.S. currency
- 12 Kilos of Powder Cocaine recovered (Street value more than \$500,000)
- 5 automobiles seized under Florida Contraband Forfeiture Act
- 8 search warrants executed
- 10 people arrested (3 to 15 years in prison)

"Those who we arrested are major drug suppliers and dealers in the drug trade. We've arrested 10 people who are major distributors and drug traffickers in our area. This is one of the most significant investigations ever done by the Bureau of Criminal Investigations Narcotics Division within the City of Sarasota," said Lt. James Rieser, Bureau of Criminal Investigations, Sarasota Police Department.
