INDICTMENT

The Grand Jury Charges:

Count One

Possession of a Firearm by a Prohibited Person
(Violation of 18 U.S.C. §§ 922(g)(5)(A) and 924(a)(2))

On or about October 25, 2012, in the Dallas Division of the Northern District of Texas, the defendant, **Jesus Gonzales**, then being an alien illegally and unlawfully in the United States, did knowingly possess in and affecting interstate and foreign commerce, firearms, to wit: ten Zastava, Century Arms International Model PAPM70, 7.62 caliber rifles; one Maadi, Century Arms International Model MISR SA, 7.62 caliber rifle; one Romarm, Century Arms International Model WASR 10, 7.62 caliber rifle; one Norinco Model Mak-90 Sporter, 7.62 caliber rifle; one Romarm, Century Arms International Model SAR 1, 7.62 caliber rifle; one Zastava, Century Arms International Model M70AB2, 7.62 caliber rifle.

In violation of 18 U.S.C. §§ 922(g)(5)(A) and 924(a)(2).


Forfeiture Notice
(18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c))

Upon conviction for any of the offense alleged in Count One of this Indictment and pursuant to 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c), the defendant, **Jesus**

Gonzales, shall forfeit to the United States of America, the following:

1. ten Zastava, Century Arms International Model PAPM70, 7.62 caliber rifles;
2. one Maadi, Century Arms International Model MISR SA, 7.62 caliber rifle;
3. one Romarm, Century Arms International Model WASR 10, 7.62 caliber rifle;
4. one Norinco Model Mak-90 Sporter, 7.62 caliber rifle;
5. one Romarm, Century Arms International Model SAR 1, 7.62 caliber rifle;
6. one Zastava, Century Arms International Model M70AB2, 7.62 caliber rifle
