The Grand Jury charges that:

U.S. DISTRICT COUFA: DISTRICT OF RHODE ISLAND

COUNT I

On or about March 11, 2011, in the District of Rhode Island, the defendant, TRINI FUENTES, who was previously convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly and intentionally possess a firearm, that is, a Hi-Standard .22 caliber revolver, serial number 1053150, in and affecting interstate and foreign commerce,

All in violation of 18 U.S.C. §§ 922(g)(1) and 924(a)(2).

COUNT II

On or about April 19, 2011, in the District of Rhode Island, the defendant, TRINI FUENTES, who was previously convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly and intentionally possess a firearm, that is, an AMT .380 caliber pistol, serial number Cl1803, in and affecting interstate and foreign commerce,

All in violation of 18 U.S.C. §§ 922(g)(1) and 924(a)(2).

COUNT III

On or about May 19, 2011, in the District of Rhode Island, the defendant, TRINI FUENTES, who was previously convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly and intentionally possess a firearm, that is, a Smith & Wesson .9mm pistol, serial number RBT4534, in and affecting interstate and foreign commerce,

All in violation of 18 U.S.C. §§ $92\frac{1}{2}(g)(1)$ and 924(a)(2).

COUNT IV

On or about June 17, 2011, in the District of Rhode Island, the defendant, TRINI FUENTES, who was previously convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly and intentionally possess a firearm, that is, a Kel-Tec .9mm pistol, serial number R9822, in and affecting interstate and foreign commerce,

All in violation of 18 U.S.C. §§ 922(g)(1) and 924(a)(2).

FORFEITURE ALLEGATION

Upon conviction of the offense alleged in Counts I through IV of this Indictment, the defendant, TRINI FUENTES, shall forfeit to the United States pursuant to 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c), the firearms identified in Counts I through IV of the Indictment.
