


Thefts of Explosives

Thefts of Explosives



Top three methods:

- Inside help (current or former employee involved)
- Door forced/broken
- Locks pried or cut



Theft or Loss of Explosives

- Must report <u>theft or loss</u> within 24 hours of discovery
- Contact ATF explosives theft hotline: 1-800-461-8841 or ATF 24-hour hotline: 1-800-800-3855
- Complete and submit ATF Form 5400.5, Report of Theft or Loss
 Explosive Materials
- Contact local authorities
- Penalties for failure to report theft include fine and imprisonment
- Forthcoming updated form will capture more information that can be used to better evaluate theft trends

Suspicious Activity

- ATF encourages industry members to report suspicious activity, e.g. delivery vehicles being followed (voluntary—not a requirement)
- Notify ATF of attempted/actual magazine break-ins
- Call 1-888-ATF-BOMB

ATF Ruling 2011-3 Alternate Locks

- Approves the use of additional locks under certain conditions.
- "Puck locks" (Die-cast bodies not allowed — only hardened steel)
- Padlocks with boron-alloy shackles
- Recessed locks
 (Jobsite boxes
 must have two
 recessed padlocks)











ATF Ruling 2010-2 Explosives Label Visibility

- Explosives must be stored so marks are visible 555.214(b)
- Clarifies application of section to specific scenarios
 - Pallets of like material
 - Rows stacked together



- Proprietor may maintain a list of explosives in pallet or stacked group
- List must be updated when materials are removed
- IOI has discretion to count entire stack/pallet



ATF Ruling 2012-2 Fireworks Storage Bins

- 555.214(c): Containers of explosive materials must be closed while being stored.
- Bins = Containers
- All salutes in 1 bin =
 Bulk Salute container





ATF Ruling 2012-5 Type 4 Magazine Floors

- Regulations require that type 4 magazines have steel or fabricated metal exterior floors
- Ruling allows wooden floors on magazine exterior, provided:
 - Must be placed on gravel, concrete pad or skirted
 - If skirted, no vegetation or other materials capable of propagating flame may be under magazine







Display Fireworks Clarification

- Aerial shells containing more than 40 grams of pyrotechnic composition
- Salutes containing more than
 130 milligrams of flash powder
- Weight limit for aerial shells does not include lift charge

Fireworks & Pyrotechnic Materials

- ATF Classification is not dependent on DOT classification (1.3 vs. 1.4)
 ✓ Verify UN codes for exemption
- Stars, quickmatch, time fuse, igniters - commonly shipped as 1.4 but are ATF regulated items
- Aerial shells over 10-inch shipped as 1.1 but ATF considers them low explosive display fireworks







Exemption Indian Agencies and Tribes

- Tribal Law and Order Act of 2010
- Authorized employees acting on behalf of agency or tribe
- Display Fireworks Materials only
- Does not exempt the manufacturing of fireworks
- Must still comply with storage requirements
- Must report theft or loss of explosives

Storage Requirements High Explosives

Includes Flash Powder and Bulk Salutes

- Type 1 permanent magazine
- Type 2 mobile or portable magazine





Type 1 and 2 Magazines

- Bullet resistant
- Fire resistant
- Weather resistant
- Theft resistant
- Ventilated
- Distance requirements







Storage Requirements Low Explosives

- Display fireworks (except flash powder and bulk salutes)
- Igniters, quickmatch, black powder, stars, etc.
- Type 4 permanent, mobile or portable magazine







Type 4 Magazines

- Fire resistant
- Weather resistant
- Theft resistant
- Two hooded padlocks
- Distance requirements

Magazines Inside Trailers and Containers



- Indoor magazine must meet construction requirements.
- No other explosives may be stored outside indoor magazine and within container/trailer.

- Mobile trailers require variance to store an indoor magazine within.
- (See June 2011 Newsletter)






Reminders...

You are required to:

- Conduct yearly physical inventory of all explosives on-hand (*record must be on file for inspection) (licensees/permittees)
- Visually inspect locks and magazines at least every seven days
- Notify the authority having jurisdiction for fire safety in the locality in which explosives are stored

Working for a Sound and Safer America New Appointments in Enforcement Programs and Services—Assistant Director and Deputy Assistant Director

r. Arthur Herbert was appointed as the Assistant Director for the Enforcement Arthur Herbert began his career with ATF in 1976. He has served as the Director of Industry Operations for the Chicago, Washington and Baltimore Field Divisions and as Division Chief of the Alcohol and Tobacco Programs Division, Mr. Herbert was selected as Deputy Assistant Director of the Office of Public and Governmental Affairs in 2009 before his appointment in EPS. Mr. Herbert is responsible for directing the development of policy guidance, exercising oversight of program implementation and technical and enforcement support to firearms, explosives and arson, and alcohol and tobacco related mission functions.



Be Prepared for Inspection

- Ensure records are available for examination
- Expect that inventory and records examinations will be time-consuming and thorough
- Ensure that a knowledgeable (responsible) person is available to answer questions and provide assistance, if necessary
- If you have any questions on what to expect, ASK!



Suggestions

- Establish a contact within local ATF office
 - Call ATF before you have a problem
 - Invite ATF to conduct training
- Frequent inventory verifications
- Educate your employees/helpers about the regulations and rulings
- Organize records in separate files
- Review security at premises
 - Consider upgrading padlocks



Should I Get an ATF Permit?

- Limitations without permit:
 - May not receive any explosive materials for pyrotechnic uses
 - May not transport any explosive materials
 - Must store explosives properly
 - Exceptions: consumer fireworks, articles pyrotechnic, black powder for use in antique firearms...



Should I Get an ATF Permit?

- \$100 for 3 years; \$50 for 3-year renewals
- ATF visit for application/renewal
- Must keep proper records
- Must store explosives properly (but so must everybody else!)
- May purchase, receive, and transport explosives
- Use ATF as a resource
