Page 2 – ATF Form 5300.13, Final Notice of Denial of Application, Revocation, Suspension and/or Fine of Firearms License

Neal A. Ostermann, 2116 Garfield, Beatrice, Nebraska 68310 ("Licensee") holds Federal firearms license #5-47-067-01-3M-33418, a dealer in firearms other than destructive devices, which was issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) pursuant to the Gun Control Act of 1968 (GCA), as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478.

On August 12, 2022, ATF issued a Notice to Revoke License, ATF Form 4500, to Licensee. This Notice was sent to Licensee's known licensed business premises. Receipt of the Notice was confirmed via USPS certified mail on August 25, 2022.

Said Notice alleged that Licensee willfully violated the provisions of the GCA and the regulations issued thereunder. The Notice further specified that if Licensee wished to challenge the revocation, he may file a request with ATF for a hearing "within 15 days after receipt of this notice." See 18 U.S.C. § 923(f)(2); 27 C.F.R. § 478.73(b). No request for hearing was filed with ATF in accordance with the provisions of the GCA.

For the reasons set forth in the Notice to Revoke License issued on August 12, 2022, the Federal firearms license held by Licensee, Neal A. Ostermann, is hereby **REVOKED**.

Accordingly, the firearms business records for Licensee's discontinued business must be sent to the ATF Out-of-Business Records Center, 244 Needy Road, Martinsburg, West Virginia 25401, pursuant to the requirements under 18 U.S.C. § 923(g)(4) and 27 C.F.R. § 478.127. The records shall be delivered within thirty (30) days following the business discontinuance.
